#### Regional Competition for journalists, vloggers, and bloggers in Moldova and Ukraine

The "EU4Youth - Unlocking the potential of young social entrepreneurs in Moldova and Ukraine" project (in short, the EUnlocking project) has announced a regional contest for journalists, vloggers and bloggers in the Republic of Moldova and Ukraine.

The theme of this competition is "Social entrepreneurship – cooperation beyond borders".

Do you know interesting social entrepreneur(s) in the Republic of Moldova and Ukraine who strengthen cooperation between the two countries and/or with another EU country, as well as brings positive impacts to the society and/or the environment? Help people get to know him/her/them. Participate in this competition to introduce your heroes to the public and win a cash prize!

#### What can I submit?

- Everything, which is important to be shared with others: you can submit an article, footage, blogpost, podcast, vlog, video, talk-shows or any multimedia content centered on the story of entrepreneurs who collaborate across the two countries and/or with other EU countries to create positive differences for the environment and their communities, especially for the disadvantaged.
- Each contestant can submit maximum 2 (two) own works.
- Materials (entries) must be originally published/broadcasted/posted between 1 October and 30 November 2021 (local time).
- Priority themes are (1) partnerships among social entrepreneurs in the Republic of Moldova and Ukraine and/or with other EU country(ies), (2) youth with social entrepreneurship, (3) workplaces for disadvantaged youth/people, (4) ecology and environmental sustainability, and (5) how social entrepreneurship contributes to regional economy (Eastern Europe).

Languages of the entries: Romanian, Ukrainian, Russian, English The deadline for submitting applications is 30 November 2021 (local time). For applicants living in Moldova, please submit your materials <u>here</u>.

## Technical requirements

If the material is published online, include the URL link directly in the respective application form. The link must be active at least until 31 December 2022.

#### Evaluation criteria

## *The relevance of the entry:*

- Relevance to the mentioned theme and topics;
- Level of coverage of social entrepreneurship topics in regional/European/international scope;
- Introducing the audience to the topic of social entrepreneurship in a fresh/innovative
- Incorporating case studies or first-hand quotes etc.

## Compliance of the material with journalistic standards:

- Accuracy of research on the topic
- Balance of opinions
- Honesty and reliability
- Non-discrimination
- Simplicity
- Coverage of the hero/heroine's story and impact of his/her social business

## Additional criteria will be evaluated \*:

- \* Points on these following criteria will not be decisive but may give an advantage:
  - Outreach the number of people who have contacted your material at least once;
  - Emotional intelligence within the writing/video piece the author's ability to understand, use, and manage emotions in a positive way to relieve stress, communicate effectively, empathize with others, overcome problems, and resolve conflicts;
  - Follow-ups of the publication (if available, please submit a proof together with your application) - further coverage of the topic in the media based on the publication results.















# #EUnlocking

The jury will assess each criteria from 1 to 10 and make their final decision until 30 December **2021**. The best material will be determined by the number of points.

Depending on the Covid situation, the winners might be invited to the awards ceremony expected to take place offline in January 2022. The specific date and location will be communicated later.
